## Call for Case Reports & Medical Images

*Journal of Clinical Diabetology* welcomes well-described reports of cases that include the following:

- Unreported or unusual side effects or adverse interactions involving medications.
- Unexpected or unusual presentations of diabetes.
- New associations or variations in diabetes.
- Presentations, diagnoses, and/or management of diabetes.
- An unexpected association between diabetes and its symptoms.
- An unexpected event in the course of observing or treating a diabetes patient.

Case reports submitted to *Journal of Clinical Diabetology* should make a contribution to medical knowledge and must have educational value or highlight the need for a change in clinical practice or diagnostic/prognostic approaches to diabetes.

Journal of Clinical Diabetology will not consider Case reports describing preventive or therapeutic interventions, as these generally require stronger evidence.

Case reports should include relevant positive and negative findings from history, examination, and investigation, and can include clinical photographs, provided these are accompanied by written consent to publish from the patient(s). Case reports should include an up-to-date review of all previous cases in the field.

Authors are encouraged to describe how the Case report is rare or unusual as well as its educational and/or scientific merits in the covering letter that will accompany the submission of the manuscript.

Case report submissions will be assessed by the Editors and will be sent for peer review if considered appropriate for the journal.
